We, the board of directors of the Company (the "**Board**"), are writing to inform you of a forthcoming change to HSBC Global Investment Funds Prospectus (the "**Prospectus**"). Our records show you own shares in one or more of the sub-funds of the Company (the "**Sub-Funds**").

## Data Outsourcing

### The Change

The Management Company, the Depositary Bank and Paying Agent, the Administration Agent, and the Registrar and Transfer Agent (the "**Entities**") acting in their respective capacities as described in this Prospectus, outsource certain activities to other HSBC entities or third-party service providers located in various jurisdictions.

The information you provided for the purpose of your investment in the Company, and which may include personal and confidential data could be transferred and stored by service providers of the Entities.

To enable Shareholder access to information and safeguard Shareholder interests, the Board has decided that, from the Effective Date (as defined below), information on the current outsourcing parties appointed by the Entities or on their behalf, which will include details of where they are located, will be available at [www.hsbc.lu/data-outsourcing](http://www.hsbc.lu/data-outsourcing). In case of additional appointments in the future, the information on the website will be updated accordingly.

In this context the term Shareholders refers to both individuals and corporate entities.

### Effective Date

The above change will take effect on the date of the next visa-stamped Prospectus. This is expected to be published on or around 28 March 2025.

### Impact on Shareholders

The Board would like to assure Shareholders that the Sub-Funds' investment objectives and/or the way they are managed and/or their risk rating will not change. There will be no change to the charges and expenses relating to the Sub-Funds following this change.
